Statement on Former Director Dr Sudhanshu Agarwal

Melbourne, Australia, October 17, 2023 – Incannex Healthcare Limited (Nasdaq: IXHL) (ASX: IHL), ('Incannex' or the 'Company') has become aware of legal claims against former director, Dr Sudhanshu (Sud) Agarwal. The public allegations against Dr Agarwal relate to business activities unrelated to Incannex. The allegations were made against Dr Agarwal on or around 13 September 2023, well after his tenure as a director in Incannex, which ceased 16 months ago in June of 2022. Whilst it is not for the board of Incannex to comment on the allegations themselves nor the validity of the allegations, the company felt compelled to make this clarification due to the number of inbound queries from shareholders.

Incannex wishes to advise that Dr Agarwal and his associated company Cannvalate Pty Ltd are no longer shareholders of Incannex. As at the top 20 shareholder report published 30 August of 2023, Dr Agarwal and Cannvalate Pty Ltd held 34.08M and 32.00M shares, respectively. Furthermore, Dr Agarwal has no title or economic benefit attributable to him from any intellectual property owned by Incannex, including patents, clinical programs, or any other company owned assets within its IP portfolio.
